***This is not the full description of P.R.I.D.E Club Summer Camp Program. Please see the Parent Handbook for complete rules, policies and procedures.**

1. I understand that *refunds/credits* will **NOT** be given for any unused portion of P.R.I.D.E. Summer Day Camp, this includes extreme behavior or repeated misbehavior by a child.
2. I understand P.R.I.D.E. Summer Day Camp reserves the right to terminate care services based on extreme behavior or repeated misbehavior by a child.
3. I understand all accounts are billed one week in advance and must be paid in full by Friday at 4:00pm of the week prior.
4. I understand a \$10 late payment fee will be charged each week on all accounts that have a balance after 4:00PM Friday.
5. I understand that there is a **late pick-up fee** (\$15 for the first minute & \$1 for each additional minute after 6pm) charge for each child picked up after 6 pm. The payment for this fee is due at the time of pick-up or the next day the child attends the program. If the fee is not paid, the child will not be allowed to stay at the program until the fee is paid. If we cannot reach you, **the police department may be contacted if you are more than 30 minutes late** picking up your child. If I am late consecutively, my child may be withdrawn from the summer camp.
6. I understand P.R.I.D.E Summer Day Camp is not responsible for lost or damaged items. Personally-owned devices (including laptops, tablets, cell phones) are NOT permitted.
7. I understand, control of entry/exit to an area in the facility by any means will be electronically controlled from the reception area and/or any other authorized individual.
8. I understand my child(ren) must be signed in & out at the Pendergast P.R.I.D.E. Club by a parent/guardian or other authorized parties identified on the registration form. Child(ren) may not sign themselves in. Individuals under the age of 18 are not permitted to sign child(ren) in or out.
9. I understand that all campers and staff will participate in all fieldtrips and activities at P.R.I.D.E Summer Day Camp. If your child displays a continuous/extreme disruptive behavior during a fieldtrip that puts his/hers and/or those around them in danger, parents/guardians will be called for immediate pick-up from the location.
10. I permit my child to travel on authorized fieldtrips by P.R.I.D.E. Summer Day Camp arranged transportation under the supervision of the P.R.I.D.E Summer Day Camp staff.
11. I grant permission for my child's photograph to be taken at P.R.I.D.E. Summer Day Camp for craft/activity purposes ONLY.
