**\*\* P.R.I.D.E. Child Care Assistance Scholarships** are awarded on a first-come, first serve basis to eligible applicants for the 2021-2022 school year. **Please read and Initial the following Statement of Understanding:**

*\*Please note, this is not a full description of P.R.I.D.E. CLUB services. Please see the Parent Handbook for complete rules, policies, and procedure.*

I understand monthly tuition payments are due **one month in advance** no later than the 15<sup>th</sup> of the month. A \$25 late fee is assessed on the 22<sup>nd</sup> of each month. Failure to submit payment fees will result in a temporary suspension of services until payment is received.

I understand that refunds/credits will NOT be given for any unused portion of the month, this includes extreme and repeated misbehavior by child.

No reduction of fees is made when children are absent including holidays/breaks. Rates are calculated based on school days only.

I understand changes in Enrollment Plan/Withdrawals may only be made between the 1<sup>st</sup> and the 15<sup>th</sup> of each month. I am aware of the \$10 Change of Plan Fee stated in the Parent Handbook. Changes will take effect the 1<sup>st</sup> day of the following month.

I understand that if the request for withdrawal form is not received before next months' tuition due date (15<sup>th</sup> of the month), I will be charged for the month.

I understand a late pick-up fee of **\$15 will be charged for each child not picked up by 6:00PM**. There is an **additional charge of \$1 per minute** that you are late. Late pick-up fees must be paid at the time of pick up or the following date of attendance. Failure to submit late pick-up fees will result in a temporary suspension of services. If we cannot reach you, **the police may be contacted if you are more than 30 minutes late** from picking up your child. Consecutive late pick-ups will result in withdrawal of services withdrawal from the program.

I understand P.R.I.D.E Club is not responsible for lost or damaged items. Personally-owned devices including laptops, tablets, gaming systems, and cell phones are NOT permitted.

I understand my child must be signed in/out at the Pendergast P.R.I.D.E. Club upon attendance by a parent/guardian or other authorized parties identified on the registration form. Children may not sign themselves in.

I grant permission for my child's photograph to be taken at PR.I.D.E. CLUB and used for craft purposes only.
